NOTIFICATION

No. B. 50016/I/2023-TRP. In exercise of the powers conferred by section 65 of the Motor Vehicles Act, 1988, the Government of Mizoram is pleased to make the following rules to further amend the Mizoram Motor Vehicle Rules, 1995 relating to registration of motor vehicles namely:-

- 1. Short title and commencement.-
- These Rules shall be called the Mizoram Motor Vehicles (Amendment) Rules, 2023.
- 2) They shall come into force on the date of their publication in the Official Gazette.
- 2. Amendment of rule 54,-

In rule 54 of the Mizoram Motor Vehicles Rules, 1995, the proviso shall be substituted by the following, namely .-

"Provided that before registering any type of vehicle including two-wheelers, the person intending to register shall obtain a Certificate from any officers of Transport Department or any agency i.e. Local Councils/Village Councils authorized by the Director of Transport declaring that he has a garage under his lawful possession or a garage to hire from other person, for parking the vehicle he intends to get registered. The certificate will be as in Form 80 appended to these rules".
