## TERMS & CONDITIONS FOR OUTSOURCING OF POLLUTION TESTING CENTRE ON BOO (BUILD, OWN, OPERATE) BASIS

- To implement the provisions of Rule 115 of the Central Motor Vehicles Rules, 1989 and in order to check the menace of air pollution, Transport Department, Gov't of Mizoram is inviting tender from the suitable bidder (Individual/Firm) to install and operate Pollution Testing Centre at Siaha, Lawngtlai, Serchhip, Mamit and Champhai Districts on BOO (Build, Own, Operate) basis for a period of 2 (two) years which will be extendable on mutual consent from both parties.
- Installation and repair cost will be borne by the Operator.
- Pollution Analyzers to be installed should be tamper proof and certified by the competent authority. All the task performed for testing of vehicles should be recorded in a tamper proof computerized system.
- The Operator will set up working office with adequate parking space to check/ test the vehicles.
- All bidders should submit the bid documents in plain paper with proper signature and complete address of the proposed testing site.
- The bidders are required to submit Earnest Money of Rs 1000.00 (Rupees One Thousand) only in the form of Banker's Cheque/Bank Guarantee from SBI or any Nationalised Banks payable in favour of the Director of Transport.
- 7. Bid without Earnest Money will be summarily rejected.
- 8. In case the Bidder is a Firm, the bidder is required to submit a photo copy of the following documents:
  - (a) Latest valid GST Registration Certificate form concerned Authorities of the State Government, as applicable.
  - (b) GST Annual Return for the Last Financial Year.

## (c) Permanent Account Number (PAN) Card.

For others, a self-attested photo copy of Voter's ID and first page of Bank Passbook.
