Sealed tenders are hereby invited by the undersigned from Government Registered Tyre Retreading Firms in COLD PROCESS repair of tyre belonging to the Transport Department as per details of works and terms & conditions mentioned below. The tenders shall be for a period of 1 (one) year from the date of issue of acceptance order or till fresh tender is floated for the same. The tenders will be received by the undersigned upto **12th February, 2024 at 12:00 Noon** and will be opened on the same day at **2:30 p.m.** Any tenderer or his/her representative may present at the time of opening of tender if he/ she so desires.

TERMS & CONDITIONS

1. The tender should be submitted in sealed cover and superscribed as "Tender for repair of Tyres" addressed to the Director of Transport.
2. Tenderers should quote the rates per item of work both in figures and in words. Alteration or correction, if any, must be initiated with date.
3. Tenderers should deposit Rs 5000/- as Earnest Money in the State Bank of India or any Scheduled Bank in the form of "Deposit at call" in favour of Director of Transport, Aizawl along with the Quotation.
4. Tenders without earnest money will be summarily rejected.
5. Tenderer should mention the name of the company from where the materials will be procured for the works.
6. Firms having franchisee should enclose valid Franchisee Certificate issued by their respective principal.
7. Rubber brands approved by the Department for use in the department vehicles are:- Indag, MRF, Elgi and Apollo.
8. Tenderers should also mention the kilometres guaranteed for each item of works.
9. Tenderers should also mention the number of tyre they can repair in a day.
10. The tender should be accompanied by certified copy of the firm's Registration certificate issued by Industry Department.
11. The Tender should be accompanied by House Tax Payee Certificate (for Tribal) and Tax Clearance Certificate (for Non-Tribal), NOC/Consent Certificate issued by the Mizoram State Pollution Control Board, Professional Tax Clearance issued by Taxation Department.
12. The successful tenderer (s) shall have to execute Agreement with the Director of Transport within 15 days from the date of issue of acceptance order. The terms and conditions of the Agreement once accepted shall be final.
13. Works allotted to the firm shall not be transferable to any other persons or firms unless the Department is compelled to do so.
14. The successful tenderers will have to collect tyres etc. only after Work order is duly issued for repair from the office of Joint Director (OP) (Store Section) and deliver the same at his own cost to the office after repair within a period of one week.
15. The successful tenderer (s) will ensure that only the approved brand of materials are used for the works. Any tyre or tyres found to perform less than the guarantee km will be given to the firms for repair free of cost.
16. The successful tenderer(s) will have to furnish a Security Deposit of Rs.10,000/- (Rupees ten thousand) only in the form of Deposit at Call pledged in favour of Director of Transport, Mizoram from any nationalized Bank at Aizawl.

17. The Security Deposit may be forfeited in whole or in part in the event of breach, on the part of the tenderers, of the terms and conditions of the Agreement.
18. The undersigned shall have the power to revoke the contractual agreement for unsatisfactory performance or any other reason at any time.
19. The undersigned is not bound to accept the lowest tender and reserves the right to reject any or all the tenders without assigning any reason.
