TERMS AND CONDITIONS

1. Quotationer should deposit 50% of the Bid Price as Earnest Money Deposit in the form of Bankers cheque/ Bank guarantee in favour of Director of Transport. This amount shall not be adjusted with the offered value. The EMD should be released after 30 days of opening the quotation.
2. The Quotationer should submit the original EMD along with Name of Bidder and Contact No. in sealed cover super scribed "QUOTATION FOR DEPARTMENT CONDEMNED VEHICLE". The Quotationer should also write the Registration No of the vehicle on the cover of the envelope.
3. Quotation without earnest money will be summarily rejected.
4. The Quotationer or his/her representative may be present at the time of opening of the quotation if he/she so desires.
5. The successful bidder should deposit full amount of the bid money within 7 (seven) days from the date of issue of the offering letter, failing which it will be treated as cancelled and the earnest money will be forfeited, and offer will be made to the next highest bidder.
6. The Successful bidder must remove the vehicle within 15 days after issue of release order, failing which Rs. 50/- (fifty) per day will be charged as Garage rent.
7. In the event of Bidder withdrew themselves from the bid twice in one financial year, that bidder should be banned and 'Black Listed' from future bidding during the existing financial year.
