OFFICE ORDER

In response to this Department 's Advertisement No. 2 of 2024-2025, written examination for the post of Enforcement Sub-Inspector under Transport Department was conducted on 14.09.2024 and personal interview was held on 28.11.2024 .

They shall be on probation for a period of 2 (two) years from the date of joining and they should join their respective place of posting within 45 days from the date of issue of this order.

They should also undergo Compulsory Basic Training at C.T.I, Sesawng.
