TERMS AND CONDITIONS

1. All bidders shall furnish the EMD/Bid security amounting ₹ 5,000 in the form of Bankers cheque/ Bank guarantee drawn on any scheduled/ nationalized bank in favour of Director of Transport along with their bid, failing which the bid shall be left archived unopened/ rejected.
2. The bidder should be Authorised Dealer having servicing station within Mizoram.
3. Authorised Dealer should enclose "Company Dealership Certificate" and rates quoted should be as per Company's price applicable for Authorised Dealer with authentic documents of proof.
4. The rates quoted shall be valid for at least 60 days and it shall include cost of body construction, taxes and initial insurance of the vehicle. Any extra charge shall be clearly mentioned in the bid documents.
5. The quotations shall be duly signed by the Authorised signatory of the firm.
6. The bid documents shall include the description of vehicle along with detail specifications.
7. The undersigned is not bound to accept the lowest valid quotation whatsoever and reserve the right to reject all or any with or without assigning any reason thereof.
8. The vehicle supplied should be a brand new and free from any glitch, failing which will result in forfeiture of bid security.
9. Successful bidder shall supply the vehicle within 60 days from the issue of supply order unless specifically mentioned in the supply order of vehicle.
10. Supply order allotted to the firm shall not be transferable to any other persons or firms unless the department is compelled to do so.
