ORDER

Transport Department, Govt. of Mizoram has taken up the Project "Development, Customization, Deployment and Management of State Wise Vehicle Tracking Platform for Safety and Environment with AIS 140 Specification" under Nirbhaya Fund for implementation of the Scheme under MoRTH. The total cost of the project is Rs. 10.40 crores which was shared between the Central Government and State Government at a ratio of 90:10. The Central Government share is Rs. 9.36 crores and the State Government share is Rs. 1.04 crores. Now that setting up of the Command and Control Centre for Vehicle Location Tracking and Emergency Alert System is completed and is functioning 24x7 in the Directorate of Transport Department, Govt. of Mizoram. Fund position as under:

As per Govt. of India, Ministry of Finance, Department of Expenditure letter no. F.No.1(13)/PFMS/FCD/2021 dt.30.6.2021 and Govt. of Mizoram, Finance Department O.M No. G.25020/21/2021-FD(FMU)/22 dt.20.1.2022, the interest earned from the fund released shall be apportioned by the SNA between the Central and the State Share as per the approved funding pattern of CSS and shall be deposited in the respective consolidated fund.

In pursuance of point no. 1 of minutes of the meeting of Project Implementation Unit held on 14.11.2024, the meeting decided that the interest accrued of Rs. 22,07,048/- be remitted to the Govt. account as per norms. Out of the total interest amounting to Rs. 22,07,048/- wherein it will be deposited between the Centre and State at a ratio of 90:10 under the following appropriate head of accounts:
