Sealed Quotations are hereby invited by the undersigned for approval of Firms and rates for supply of various types of tyres, tubes and flaps mentioned in the Annexure to Transport Department as per details of terms & conditions mentioned below. The quotation should be submitted to the undersigned on or before 13<sup>th</sup> March, 2025 upto 12:00 Noon and will be opened on the same day at 2:30 P.M.

**TERMS & CONDITIONS**

1. Quotationer should be a registered firm under The Mizoram Goods and Services Tax Act,2017. The Quotation should be submitted in sealed cover super scribed as "Quotation for Fixation of rates of tyres, tubes and flaps".
2. Quotationer should quote the rates per item of tyre, tube and flaps both in figure and in words. Alteration and correction, if any, must be initialed with date.
3. Authorised Dealer should enclose "Company Dealership Certificate" and rates quoted should be as per Company's printed price applicable for Authorised Dealer with authentic documents of proof.
4. The Quotation should be accompanied by House Tax Payee Certificate (for Tribal) and Tax Clearance Certificate (for Non-Tribal).
5. The successful Quotationer(s) shall supply only the genuine brand of tyre, tubes and flaps.
6. Supply order allotted to the firm shall not be transferable to any other persons or firms unless the department is compelled to do so.
7. The successful Quotationer(s) will have to furnish a Security Deposit of ₹ 20,000/- (Rupees twenty thousand) only in the form of Bank Guaranty or Bankers Cheque pledge in favour of Director of Transport, Mizoram from any Nationalised Bank at Aizawl which may be released after complete supply of the item.



8. The Security Deposit may be forfeited in whole or in part in the event of breach of the terms and conditions of the Agreement on the part of the tenderers.

9. The undersigned shall have the power to revoke the contractual agreement for unsatisfactory performance or any other reason at any time.

10. The undersigned is not bound to accept the lowest tender and reserves the right to reject any or all the tenders without assigning any reason thereof.


